
Sir / Madam,

I am directed by the Council as per above referred references that, your institution is permitted to continue the ANM programme with an intake capacity of 20 (Twenty) seats per year for the A.Y.2016-17 subject to time bound compliance of mandatory condition as follows :-

1. To upload and submit the details of teaching staff only registered with this council as per norms.
2. To upload and submit the details of recent permission for clinical experience of students from competent authority for UPH, RPH and Hospital on or before 30th October 2016.
3. The online submission and uploading e-Adhar Card based student's enrollment on software only for 20 students between 1st to 30th October 2016 for the A.Y. 2016-17.
4. This continuation of affiliation for ANM Programme will automatically come to an end without notice in case of your failure to comply condition of clinical affiliation and teaching staff on or before 30th October 2016.
5. There will be a surprise inspection to confirm the compliance submitted during the A.Y. 2016-17.
6. All affiliated institutions should pay bed affiliation fees every year & inspection fees of Rs. 15,000/- should be paid once in 03 years
7. You are advised to screen website frequently for directions/ notification issued by the undersigned from time to time.

In case the information furnished by you is false or misleading then in that event the MNC reserves the right to withdraw the affiliation without any notice and further action as deemed fit would be taken against the institution as per section 25 and 26 of the Maharashtra Nurses act 1966 for the above said programme.
